The City Administration and the Agency staff were directed to continue to develop advocacy principles for the protection of redevelopment agencies, affordable housing and economic development programs and to continue to assess potential impacts on the Agency's and City's programs and debt obligations in the event redevelopment agencies are eliminated. 8.2 Authorization for the Executive Director and City Manager to negotiate and execute a Cooperation Agreement relating to funding certain Redevelopment Agency capital improvements, public improvements and obligations.
